

Competition Terms and Conditions

World Cup Prediction Promotion — draft for legal review. This promotion is run by MBE UK, Unit 1, Petre Court, Petre Road, BB5 5HY, Clayton-le-Moors.

2. Eligibility

1. Open to UK residents aged 18 or over, excluding employees of Fortidia UK, MBE franchise partners and their staff, and their immediate family members.
2. By entering, participants confirm they meet these eligibility requirements.
3. MBE UK reserves the right to request proof of age or identity before releasing a prize.

3. Promotion Period

4. Entries open at **16.07. 9:00** and close at **18.07. 22:00**.
5. Entries received after the closing time will not be counted, regardless of when they were submitted.

4. How to Enter

6. Entrants visit a participating MBE centre in person and submit one entry via the entry card provided, or via the online entry form linked by QR code in the centre, predicting: (a) which team will win the FIFA World Cup Final and third place game (b) the time of the first goal scored in both matches (mm:ss from kickoff).
7. No purchase is necessary to enter.
8. Limit of one entry per person. Duplicate entries from the same person will be disqualified.
9. Entries must include a valid name and contact details (phone or email) so MBE UK can notify a winner.

5. Determining the Winner

10. The winning entry is the one that correctly predicts the winning teams and comes closest to the actual time of the first goal.
11. The Promoter's decision on the winning entry is final.

6. The Prize

12. The prize is £100 off MBE services, including packing, shipping and printing. The exact available services depend on the specific participating service centres.
13. One prize will be awarded across the UK and must be used within 12 months of the winner being announced.

7. Winner Notification

14. The winner will be contacted using the details provided on their entry within three working days of the Final.
15. If a winner cannot be reached within 14 days of notification, MBE UK reserves the right to award the prize to the next closest eligible entry.
